The transformation of political party system, political elites and youth political organisations in Lithuania are examined in light of democratisation in other post-communist countries. By linking theories of democratisation and elites to actual

events, the book provides an analytical framework for interpreting political regime change and development in Lithuania. The book is based on five assumptions: (1) democratisation in Lithuania belongs to a OCyWestern typeOCO of democratic development; (2) elites and nationalism were the major forces in modernisation; (3) Lithuanian elites have used the favourable conditions of perestroika and were the major actors in regime transformation; (4) the crop of political elites in Lithuania undergoes a generational change, and

youth political organisations are very important in this process as they serve as schools for future politicians; and (5) class theory is less useful than elite theory when analysing the process of democratisation in Lithuania."

The Impact of Foreign Direct Investment on Economic Growth of Lithuania Laura Cerkasaite

2013 Foreign direct investment (FDI) has increased rapidly in Lithuania over the past twenty years and many researchers link the increase of FDI to economic growth. This paper addresses the important question of whether foreign direct investment enhances economic growth of Lithuania. The main objective of the master thesis is to analyze empirically the impact of FDI on the GDP per capita growth rate, using quarterly data from 2002 to 2012. VEC model with cointegration technique is applied to investigate the relationship between GDP per capita growth rate and labor force, human capital,

trade openness, gross capital formation and FDI. The analysis focuses on both short-run and long-run effects of FDI on economic growth of Lithuania. The papers findings reveal that FDI negatively impacts economic growth of Lithuania in the long-run, in addition to this, EC model estimates suggest that economic growth in Lithuania is not particularly sensitive to FDI stocks in the short-run. According to the short-run analysis, impact of FDI on economic growth is not significant in the case of Lithuania. Finally, the paper offers some recommendations linked to FDI to enhance the economic growth of Lithuania.

A potential problem in studying SWB across societies is that of cultural relativism: if societies have different values, the members of those societies will use different criteria in evaluating the success of their society. By examining, however, such aspects of SWB as whether people believe they are living correctly, whether they enjoy their lives, and whether others important to them believe they are living well,
